This role is part of the Legal & Proccurement team. The Legal function of the team provides strategic, high quality, cost effective and efficient legal advice to e Manatū Waka and Ministers, concentrating on activities which require Ministry-specific skills, or which are regarded as core activities of the Ministry. They oversee the management of legal risk in the areas of legislative change and process, statutory powers, requests for official information, contracts and other departments' legislation.

The role of the Senior Solicitor is to work in partnership to provide high quality, cost effective and efficient legal advice to the Ministry and Ministers.

Supporting the Privacy Officer by:	Providing legal advice on Official Information Act 1982 and Privacy Act 1988 requests and liaison with the Ombudsman's
	office and Privacy Commissioner regarding complaints.
Contributing to instruction on litigation by:	Instructing Crown Solicitors and Crown Counsel on litigation involving Ministers or the Ministry, including prosecutions under the Submarine Cables and Pipelines Protection Act 1996.

# Ka tāea te aha | Capabilities

Delivery Leadership	Senior solicitors work on and often have a leadership role in complex, ambiguous and sensitive work. Senior solicitors are skilled at scoping a piece of work and making connections to related areas of work to deliver the result the Ministry needs. They effectively plan and manage projects, and anticipate issues before they arise. Senior solicitors deliver and work with others to deliver products that are fit-for-purpose, timely, and high quality.
Professional Capability	Senior solicitors apply well-developed professional knowledge and skills to their work. Senior solicitors are capable of working with minimal supervision but seek guidance on complex issues, and test possible solutions to problems. They know and use a range of techniques, models and frameworks relevant to their work, and use the most appropriate approach in a given situation.



Self and team focus	Senior solicitors are honest, courageous, curious, self-aware, agile and resilient. Senior solicitors focus on developing and cementing their professional skills so that they have a deep tool kit. They build capability within their team by pro-actively supporting more junior staff on core skills, stakeholder engagement, planning, and navigating through complex issues. Senior solicitors model these behaviours.
Engagement	Senior solicitors are connected outside the team and the Ministry – they are visible, valued and operate across a range of networks. Senior solicitors develop, build and share knowledge, collaborate with others, and influence the agenda. They represent the Ministry and are trusted advisers.
Te Manatū Waka contribution	Senior solicitors understand the Ministry's priorities and objectives, and contribute to accomplishing Ministry goals. Senior solicitors get involved across the Ministry. They foster a culture of learning, share their knowledge and experience, and help to challenge thinking.
